## Nippers Exclusive Board Use Agreement (Parent copy)

I \_\_\_\_\_\_\_ hereby agree to the exclusive use of a nipper board from Newport Surf Life Saving Club ('the Club') for the Nipper 2016/2017 season, which is scheduled to end in March 2017.

The child specified on this agreement will have exclusive use of the allocated club board throughout the season for the purpose of training and competition.

In entering this agreement, I agree to abide by the following conditions;

- 1. The **fee** for the season is \$50/\$75/\$100/\$150/200/ other.
- 2. The board may not be used by any other person at any time without the Club's consent.
- 3. I accept that the board is in good **condition**, unless any defects are specified as drawn or in writing at the time of taking the board on the following form.
- 4. After every use **Boards should be washed in fresh water**, particularly the neoprene handles.
- 5. Boards must be stored in a dry, suitably ventilated area using padding, and/or a cover, out of weather, sun and water. Boards should not be stood on their ends without padding. Care should be taken of the nose and tail in particular. Padding is to be used between boards when using a stack method on a car and straps and ties should be sufficient to prevent movement but not leave marks on the board. Temperature extremes are to be avoided such as long periods in a locked vehicle. Windows should be left adjusted to allow airflow.
- 6. **Damage** sustained during training or competition sessions is NOT covered by the club.
- 7. All repairs to boards are to be completed by an **approved repairer** by the club and must be notified to **Club Gear Steward Nick Rogers Tel 0425 262 753.**
- 8. On **return** of the board, any damage found in addition to the original condition description will be repaired at the lenders expense.
- 9. I acknowledge that I am responsible for **delivering and collecting** boards from the repairer. Boards must be maintained in a water-tight condition and as such, all damage to the board must be repaired as soon as practicable. Damaged boards cannot be used.
- 10. If my membership or that of my child's lapses for any reason, or if the board is not used for club training, or if the club deems it necessary, the board must be returned immediately in the original condition described, the agreement is considered terminated. I acknowledge that if I do not return the board to the Club when instructed, I will forfeit the right to continued exclusive use of the board and will have no right to a refund.

- <sup>11.</sup> The Club Board Exclusive Use Agreement will be administered by a member of the Nipper Committee or such person as they nominate from time to time.
- 12. The agreed fee is to be paid and the Board Exclusive Use Agreement signed prior to any agreement being deemed active and any board being used.
- 13. If the board is damaged beyond repair, stolen or lost then full replacement cost of the board must be paid.<sup>1</sup>
